XIAMETER™ OFX-0193 Fluid is soluble in water, alcohol and hydroalcoholic systems. It is stable in water systems. It can be added to heated mixtures up to 90°C (194°F).

Incorporate XIAMETER™ OFX-0193 Fluid by adding 6 - 10% to the diluent phase by low shear mixing. The exact dosage levels needs to be assessed on a case-by-case basis.
